PRIVACY NOTICE provided by May & Co & May & Co Management Ltd

Relating to

This privacy notice explains what personal data (information) we hold about you, how we collect it and how we use and may share information about you during our management of your property and after it ends. We are required to notify you of this information under the General Data Protection Regulation.

Please ensure you read this notice (sometimes referred to as a 'privacy notice') and any other similar notice we may provide to you from time to time when we collect or process personal information about you. This privacy notice contains important information on who we are, how and why we collect, store, use and share personal information, your rights in relation to your personal information and on how to contact us and supervisory authorities in the event you have a complaint.

WHO WE ARE

May & Co and May & Co Management Ltd collect, use and are responsible for certain personal information about you. When we do so, we are regulated under the General Data Protection Regulation, which applies across the European Union (including in the United Kingdom) and we are responsible as 'controller' of that personal information for the purposes of those laws.

In this privacy notice, references to 'we' or 'us' means May & Co and May & Co Management Ltd.

DATA PROTECTION PRINCIPLES

We will comply with the data protection principles when gathering and using personal information, as set out in our GDPR data protection policy.

THE PERSONAL INFORMATION WE COLLECT AND USE: INFORMATION COLLECTED BY US

In the course of renting and or managing your property or block, we may collect the following personal information when you provide it to us:

Name, address, home and mobile telephone numbers, email address, profession, bank details, past addresses, passport photograph, mortgage details.

The provision of Contact details is required from you to enable us to perform our contract as agents appointed for and on behalf of the landlord, RTM or other responsible person. We will inform you at the point of collecting information from you, whether you are required to provide the information to us.

THE PERSONAL INFORMATION WE COLLECT AND USE: INFORMATION COLLECTED FROM OTHER SOURCES.

We also obtain personal information from other sources as follows: Credit score from Homelet for the purposes of referencing.

HOW WE USE YOUR PERSONAL INFORMATION

We will typically collect and use this information for the following purposes: For the performance of a contract you have with our client, the landlord and pursuant to which we are appointed as their agent.

For the purposes of our legitimate interests or those of a third party but only if these are not overridden by your interests, rights or freedoms.

We seek to ensure that our information collection and processing is always proportionate. We will notify you of any material changes to information we collect or to the purposes for which we collect and process it.

WHO WE SHARE YOUR PERSONAL INORMATION WITH

We routinely share the following categories of personal data:

We will share personal information with law enforcement or other authorities if required by applicable law.

We will not share your personal information with any other third party.

WHERE YOUR PERSONAL INFORMATION MAY BE HELD

Information may be held at our offices, third party agencies (Referencing agency, Inventory agents) service providers (Utilities), representatives and agents as described above.

We have security measures in place to seek to ensure that there is appropriate security for information we hold including those measures detailed in our GDPR data protection policy.

HOW LONG YOUR PERSONAL INFORMATION WILL BE KEPT

We will hold your contact details for six years e.g. The period we are required to retain this information by applicable UK Tax law (Currently six year) or for as long as we manage the property.

REASONS WE CAN COLLECT AND USE YOUR PERSONAL INFORMATION

We rely on Contract fulfilment as the lawful basis on which we collect and use your personal data when:

we need to use the information to comply with our contractual fulfilment we need to use the information to perform a contract with you; and or it is fair to use the personal information either in our interests or someone else's interest, where there is no disadvantage to you. This can include where it is in our interests to contact you about products and services, market to you, or collaborate with other to improve our services.

We rely on Legal obligation as the lawful basis on which we collect and use your personal data

Prescribed information

YOUR RIGHTS

Under the general data protection regulation, you have a number of important rights free of charge. In summary, those include rights to:

Fair processing of information and transparency over how we use your personal information Access to your personal information and to cetain other supplementary information that this privacy notice is already designed to address

Require us to correct any mistakes in your information which we hold
Require the erasure of personal information concerning you in certain situations
Receive the personal information concerning you which you have provided to us, in a
structured, commonly used and machine readable format and have the right to transmit
those data to a third party in certain situations

Object at any time to processing of personal information concerning you for direct marketing

Object to decisions being taken by automated means which produce legal effects concerning you or similarly significantly affect you

Object in certain other situations to our continued processing of your personal information Otherwise restrict our processing of your personal information in certain circumstances Claim compensation for damages caused by our breach of any data laws

Those processing your information will do so only in an authorised manner and are subject to a duty of confidentiality.

We also have procedures in place to deal with any suspected breach where we are legally required to do so.

HOW TO COMPLAIN
